ORDINANCE NO. 2-2015 FOXBURG BOROUGH CLARION COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF FOXBURG, CLARION COUNTY, PENNSYLVANIA, PROVIDING FOR THE AMENDMENT OF ORDINANCE #1-2005 TO PROVIDE FOR THE ISSUANCE OF PERMITS TO VENDORS WITHIN THE LIMITS OF PUBLIC HIGHWAYS OF THE BOROUGH.

WHEREAS, Foxburg Borough has determined that it is in the best interest of the Borough to make certain changes and amendments to its Vendor Permit Ordinance, being Ordinance #1-2005.

WHEREAS, Foxburg Borough desires to Amend Ordinance #1-2005 to provide for the setting of fee each year at the annual meeting for the issuance of vendor permits.

NOW THEREFORE BE IT ENACTED AND ORDAINED BY THE COUNCIL OF THE BOROUGH OF FOXBURG AND IT IS HEREBY ENACTED AND ORDAINED:


The following Section of the Foxburg Borough Vendor Permit Ordinance shall be revoked, repealed, and amended as follows:

1. Section 28 shall be revoked and amended to read as follows:

No person shall carry on or conduct any action or sale of wares or merchandise within the limits of the public highways of said Borough and no transient dealer, huckster, or peddler shall offer or expose to sale any wares within said Borough without having first procured from the Borough thereof a permit, which shall state the name of said person, the number of days such permission is granted, the character of the goods to be offered for sale, and shall not be issued until such applicant shall have paid to the Borough a fee to be set annually by resolution of the Borough Council at the annual meeting. This section shall not apply to any non-profit organization.

- 2. **Ratification.** All other provisions of Ordinance #1-2005, not otherwise addressed, amended or revoked herein are hereby ratified and confirmed.
- 3. **Effective Date.** The provisions of this Ordnance shall become effective immediately upon adoption by the Council of Foxburg Borough.

A ORDINANCE OF THE BOROUGH OF FOXBURG, CLARION COUNTY, PENNSYLVANIA, TO AMEND SECTION 8 AND SECTION 28 OF FOXBURG BOROUGH'S ORDINANCE NUMBER TWO.

IT IS HEREBY RESOLVED, effective immediately, that the Borough hereby amends Section 8 of Ordinance Number Two, to read as follows:

"SECTION 8. (a) No person shall allow any horse, cow, pig, dog, or other animal, chicken or other fowl, owned by or in charge of such person to be at large upon any public highway within said Borough. Any such animal or fowl found upon such public highway not under management and control of any person shall be held and deemed at large and the owner in charge thereof to have violated this Ordinance.

(b) No person, firm or corporation shall keep any cow, pig, horse, chicken, goose, goat or other barnyard animal, nor construct or maintain any pen therefore, at any place in the Borough of Foxburg."

IT IS HEREBY RESOLVED, effectively immediately, that the Borough hereby amends Section 28 of Ordinance Number Two, to read as follows:

"SECTION 28. No person shall carry on or conduct any action or sale of wares or merchandise within the limits of the public highways of said Borough and no transient dealer, huckster, or peddler shall offer or expose to sale any wares within said Borough without having first procured from the Borough thereof a permit, which shall state the name of said person, the mumber of days such permission is granted, the character of the goods to be offered for sale, and shall not be issued until such applicant shall have paid to the Borough thereof at the rate of Five calendar quarter, provided that this section shall not apply to any persons specifically permitted by law to make such sale and exempt from the requirements of this section."

The Borough Solicitor is directed to file a copy of this Ordinance at the Clarion County Courthouse.

If any section of this Ordinance shall be found to be invalid, the other sections of this Ordinance shall not be affected thereby.

All Ordinances or parts thereof in conflict herewith be and the same are hereby repealed.

THIS ORDINANCE shall be effective within five (5) days after adopted by the Council and approved by the Mayor.
